ADOPTION OF A PROJECT BY-LAW 2024-R-005 ON CONTRACTUAL **MANAGEMENT**

WHEREAS

By-law number 2022-R-005 on contract management was adopted by the Municipality on December 20, 2022, in accordance with article 938.1.2 of the Municipal Code of Québec ("MC");

WHEREAS

the Act to amend the Act respecting municipal taxation and other legislative provisions (S.Q. 2023, chapter 33), assented to on December 8, 2023 (Bill 39), as well as the Act to enact the Act to protect elected municipal officials and promote the unimpeded performance of their duties and to amend various legislative provisions respecting municipal affairs (S. Q. 2024, chapter 24), assented to on June 6, 2024 (Bill 57), amend certain provisions of the CM regarding certain measures that may be adopted by municipalities in their contract management by-laws;

WHEREAS

it is necessary to amend the present Contract Management Bylaw to add the provisions made mandatory by these laws and to add optional measures concerning the awarding of certain contracts to a municipal officer or council member when the applicable conditions are met;

WHEREAS a copy of this project by-law was delivered to each member of Council no later than two legal days prior to this meeting, and all members of Council present declared having read it and renounced to its reading;

WHEREAS the president of the meeting mentioned the purpose of the project by-law and its scope;



BY-LAW 2024-R-005

ADOPTION OF THE PROJECT BY-LAW 2024-R-005 FOR THE CONTRACTUAL MANAGEMENT AND REPLACING BY-LAW 2022-R-005

A notice of motion was given on November 19th, 2024 by the councillor **Jean-Roger Dumas** that at a subsequent sitting he will present the by-law 2024-R-005 on contractual management.

WHEREAS By-law number 2022-R-005 on contract management was

adopted by the Municipality on December 20, 2022, in accordance with article 938.1.2 of the Municipal Code of

Québec ("MC");

WHEREAS the Act to amend the Act respecting municipal taxation and

other legislative provisions (S.Q. 2023, chapter 33), assented to on December 8, 2023 (Bill 39), as well as the Act to enact the Act to protect elected municipal officials and promote the unimpeded performance of their duties and to amend various legislative provisions respecting municipal affairs (S. by-laws;

WHEREAS it is necessary to amend the present Contract Management By-

law to add the provisions made mandatory by these laws;

WHEREAS a notice of motion was given and a draft by-law was tabled at

the meeting of November 19, 2024;

CONSEQUENTLY, it proposed by **Jarvin Joncas**, seconded by **Mitchell Lawless** and unanimously resolved that this by-law be adopted and that it be ordered and decreed as follows:

1. Article 8 of By-law number 2022-R-005 on contract management is replaced by the following article:

"ARTICLE 8: Whenever possible and in the interest of the Municipality, Quebec or otherwise Canadian goods and services, as well as companies with an establishment in Quebec or elsewhere in Canada, are preferred to any other competitor when awarding a contract by mutual agreement or when sending out a written invitation to tender when the amount of the expenditure is below the threshold determined by the Minister requiring that a public call for tenders be made.

In the case of mutual agreement contracts, the Municipality favors requesting quotes from these companies over any other competitor, when such requests are justified. In the event of a tie in price, quality of service or, more broadly, any offer that is comparable in its essential elements between a Québec company and a Canadian company, the Municipality favours awarding the contract to the Québec company.



For contracts awarded following a written invitation to tender, if it is not possible or not in the best interest of the Municipality to limit itself to these persons, the Municipality will review its requirements to determine whether a new wording can be used to favour them prior to sending out invitations to tender. If, despite this review of the requirement, it remains necessary or in the interest of the Municipality to include persons who do not meet the objective of the first paragraph, the Municipality may revise its contracting strategy to consider awarding the contract by mutual agreement, where permitted. When circumstances do not allow or justify favoring such companies, the Municipality may enter into a contract with another competitor."

2. Article 9 of By-law number 2022-R-005 on contract management is replaced by the following article:

"ARTICLE 9: When the Municipality uses the measure in Article 8 of this by-law, it shall rotate co-contractors when awarding contracts by mutual agreement or inviting bids, if this is possible and in its interest. This rotation must be carried out according to the same criteria as those already developed for the rotation of suppliers who are awarded mutual agreement contracts above the monetary threshold of \$25,000 under the provisions of the present contract management by-law, with the necessary adaptations."

Entry into force and publication

The present by-law will come into force according to the law and will be published on the Municipality website. A copy of this present by-law is sent to the MAMH.
