# APPROPRIATION OF UNAPPROPRIATED OPERATING SURPLUS FOR THE RESERVE FOR EXPENSES RELATED TO THE HOLDING OF AN ELECTION

WHEREAS the Act to amend the Act respecting elections and referendums in

municipalities, the Act respecting municipal ethics and professional conduct and various legislative provisions, known as "Bill 49", will

come into force on November 5, 2021;

WHEREAS that as of January 1, 2022, municipalities must establish a fund

reserved for the financing of expenses related to the holding of an election, in accordance with sections 287.1 and 278.2 of the Act

respecting elections and referendums in municipalities;

WHEREAS that the cost of the next general election is presumed to be at least

equal to the cost of the last general election or the previous one

(whichever is greater);

WHEREAS that in order to comply with sections 278.1 and 278.2 of the Act

respecting elections and referendums in the Municipality of Blanc-Sablon, the municipality must allocate a sum of \$2,000 to the fund reserved for expenses related to the holding of an election for the

fiscal year ending December 31, 2022;

**CONSEQUENTLY**, it is proposed by **Johanne V. Beaudoin**, seconded by and **Daisy Drudge** unanimously resolved that the Municipality of Blanc-Sablon allocate an amount of \$2,000 to the fund reserved for expenses related to the holding of an election for the fiscal year ending December 31<sup>st</sup>, 2022 and to draw this amount from the unrestricted

operating surplus.

SALE OF LAND (LOT 5 931 199) IN THE VILLAGE OF LOURDES-DE-BLANC-SABLON TO MADAM SHIRLEY LANDRY BEAUDOIN FOR AN **AMOUNT OF 868,59\$** 

**WHEREAS** Mrs. Shirley Landry Beaudoin has put in a requested to the

Municipality of Blanc-Sablon to purchase land 5,931,199;

**WHEREAS** the Municipality has no use for this land and that Mrs. Landry

Beaudoin has always used it as her own;

**WHEREAS** for security and insurance reasons it is to the advantage of

the Municipality to proceed with the sale of this land;

CONSEQUENTLY, it is proposed by Daisy Drudge, seconded by Johanne V. Beaudoin and unanimously resolved to sell land 5,931,199 to Mrs. Shirley Landry Beaudoin for an amount of \$868.59. This resolution repeals resolution 2021-032

All fees for the transfer of land lot 5 931 199 are paid by the buyer. The Acting General Director, Karine Benoit is authorized to sign all documents related to this sale of land.

**WHEREAS** 

that under this Act, an RCM may enter into agreements with government departments and agencies and, where applicable, with other partners, concerning its role and responsibilities with respect to the exercise of powers, particularly for the implementation of regional priorities and the adaptation of government activities to regional particularities:

**WHEREAS** 

that the North Shore Steering Committee adopted the FARR-OVT regional priorities on June 27, 2017 and revised them on June 5,

WHEREAS

that the draft agreement responds to priority 1 "Recognize the North Shore and its specificities as an atypical region" and priority 5 "Strengthen the capacity to act of North Shore residents and their communities" by creating a Fund that adapts to the reality of the MRC du Golfe-du-Saint-Laurent;

**WHEREAS** 

the MRC wishes to continue the work of the sectoral agreement for the reinforcement of the accompaniment of the municipalities of the MRC in the realization of the accompaniment plan of each of the municipalities, in order to support the realization of projects in municipal management so that the municipalities respect their municipal obligations;

CONSEQUENTLY, it is proposed by Colin Shattler, seconded by Johanne V. Beaudoin and unanimously resolved to renew the sectoral agreement for the reinforcement of the accompaniment of the municipalities of the MRC 2023-2028;

**TO INJECT** 

the amount of \$5,000 per year for 3 years and that the said amount be taken from the general funds;

TO AUTHORIZE Karine Benoit, Acting Director General, to sign all documentation related to this sectoral agreement.

CONSTRUCTION OF A NEW STREET, FIVE (5) DUPLEXES AND ONE (1) QUADRUPLEX BY THE CENTRE DE SERVICES SCOLAIRES DU LITTORAL

**WHEREAS** 

that the Centre de Services Scolaires du Littoral has submitted a request to build a new street, five (5) duplex residential buildings and one (1) quadruplex residential building on lot 5 931 447, Cadastre of Quebec, located in the village of Lourdes-de-Blanc-Sablon;

**WHEREAS** 

that the Centre de Services Scolaires du Littoral proposes to assume the total cost of water, sewer and road infrastructure work related to the construction of a new street, five (5) duplex residential buildings and one (1) fourplex residential building;

**WHEREAS** 

that the Centre de Services Scolaires du Littoral agrees to transfer the water, sewer and road infrastructures to the Municipality for future maintenance, free of charge;

**WHEREAS** 

the Centre de Services Scolaires du Littoral has proposed a memorandum of understanding for the construction, transfer and assumption of responsibility of the infrastructures, street and water and sewer services;

the memorandum of understanding states that the Municipality will become the owner of the street and adjacent infrastructures. These installations will become an integral part of the municipal network and, for the future, they will be maintained by the Municipality like any other section;

**CONSEQUENTLY**, it is proposed by **Colin Shattler**, seconded by **Daisy Drudge** and unanimously resolved to accept the memorandum of understanding with the Centre de Services Scolaires du Littoral for the "construction, transfer and assumption of responsibility of the infrastructures, street and public services", and this, with the following conditions:

- the plans and specifications for the work for the street and the water and sewer systems be done by engineers accepted by the Municipality and that this work be under the supervision of said engineers or by persons under the control of the Municipality;
- the Acting Director General, Karine Benoit is mandated to sign all documents related to this project.
